Pre-Bid Conference. The pre-bid conference for this project will be held on Tuesday, May 2, 2017 at 1:00pm, at Airport Conference Room. All bidders are required to examine the site to become familiar with all site conditions.

Bid Conditions. The bidder is required to provide all information as required within the Contract Documents. The bidder is required to bid on all items of every schedule or as otherwise detailed in the Instructions to Bidders.

Each proposal must be accompanied by a bid guaranty in the amount of five (5) percent of the total amount of the bid. The bid guaranty may be by certified check or bid bond made payable to St. Charles County.

Bids may be held by St. Charles County for a period not to exceed 120 calendar days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The right is reserved, as St. Charles County may require, to reject any and all bids and to waive any informality in the bids received.

Construction for this project is expected to take 45 Calendar Day(s).

Equal Employment Opportunity and Affirmative Action Requirement. In accordance with the Davis-Bacon Act, and the Missouri Prevailing Wage Law, the Contractor will be required to comply with the wage and labor requirements and to pay minimum wages in accordance with the schedule of wage rates established by the United States Department of Labor and the Missouri Division of Labor Standards, respectively. The highest rate between the two (Federal and State) for each job classification shall be considered the prevailing wage.

62 **DBE Requirement.** This project is subject to the requirements of 49 CFR Part 26 Disadvantaged Business
63 Enterprise Participation. The owner has established a contract goal of 12% percent participation for small
64 business concerns owned and controlled by qualified disadvantaged business enterprises (DBE). The bidder
65 shall make and document good faith efforts, as defined in Appendix A of 49 CFR Part 26, to meet the
66 established goal.

68 The apparent successful competitor will be required to submit the following information as a condition of bid
69 responsiveness: (1) the name and address of DBE firms that will participate in the contract; (2) a description of
70 the work that each DBE firm will perform; (3) the dollar amount of the participation of each DBE firm
71 participating; (4) written documentation (signed contract proposal) of the bidder's commitment to use DBE
72 subcontractor whose participation it submits to meet the contract goal; and (5) if the contract goal is not met,
73 evidence of good faith effort, as described in Appendix A to 49 CFR Part 26.

75 The apparent successful competitor must provide written confirmation of participation from each of the DBE
76 firms listed in their commitment with the proposal documents as a condition of bid responsiveness.
