2. Status of Funding

a. Award of contract is conditioned upon MoDOT concurrence and the receipt of a grant.

3. Review of Project

- a. Description of the Scope of Work
 - i. Removal of existing asphalt apron and replacement with a new full depth concrete pavement section. 6" P-501 PCC, 6" P-209 crushed aggregate base rock, 12" P-155 Lime Treated Subgrade. Drainage improvements included.
- b. Time of Completion: 68 TOTAL Calendar Days
 - i. Includes anticipated rain days from historical data.
- c. Liquidated Damages: \$1,500 per Calendar Day
 - i. Liquidated Damages will be strictly enforced.

4. Bidding of Project

- a. Bid Opening: May 1, 2017, 2:00 P.M.
 - i. Bids will be publicly opened and read at 2:00 P.M. in the City Council Chambers of the City of Macon, City Hall, 106 W. Bourke, Macon, Missouri 63552.
- b. City reserves the right to award to the apparent lowest qualified bidder.
- c. Unbalanced Bids. Proposals are subject to consideration as being irregular if the proposal contains unit prices that are obviously unbalanced. Irregular proposals may be rejected.
- d. Bids may be held for up to 120 calendar days.
- e. Award of project is contingent upon the Owner receiving Federal funding assistance.
- f. A Bid Guarantee in the amount of 5% of the Bid is required at the time of the Bid submittal.
- g. Target Notice-To-Proceed: The targeted date is July 10, 2017. Receipt of all necessary federal funds in a timely manner may impact this date.

6. DBE Participation

- a. Goal for Contract: 6.0%
- b. Good Faith Effort: Bidder must demonstrate that they made good faith efforts to achieve participation with DBE firms. This requires that the bidder show that it took all necessary and reasonable steps to secure participation by certified DBE firms. Mere pro forma efforts will not be considered as a good faith effort.

Actions constituting evidence of good faith efforts are described in Appendix A to 49 CFR Part 26. Such actions include but are not limited to:

- f. Execution of subgrade stabilization following promptly by base rock installation.
- g. Paving Operations.
- h. Protection of NAVAIDS.
- i. Execution of Utility and Electrical Work.
- j. Final Clean Up.

- d. Per the project manual, Quality Control testing is provided by the Contractor (successful bidder) and Quality Assurance testing is provided by the Owner (City of Macon). Recommendation for payment of contract work items will be based on Quality Assurance Testing.
