Job Special Provisions (JSP):

1. Revise JSP J (MODIFICATION TO ARTICLE 14 OF SECTION 1100 GENERAL CONDITIONS), Section 14.2 as follows:

Application for Progress Payment:

14.2. At least six calendar days before the end of a month-Following the 2017 Contract Progress Payments schedule (attached to the addendum), the ENGINEER shall prepare an Application for Payment (Pay Estimate) based upon the quantities of WORK complete as of the previous day. For an item of WORK to be considered complete, the WORK must be satisfactorily performed, all submits involving materials used in the WORK approved by the ENGINEER, and the results of all required testing of the WORK

received by the ENGINEER. The ENGINEER shall give the CONTRACTOR the opportunity to review the Application for Payment prior to submittal for payment. The ENGINEER may recommend payment on the basis of materials and equipment not incorporated in the Work but delivered and suitably stored at the site, or at another location agreed to in writing. In order for the ENGINEER to make such recommendation, the CONTRACTOR must submit a bill of sale, paid invoice or other documentation substantiating the quantities and actual cost of the material, all of which will be satisfactory to OWNER.
