- 1. Item 9 APWA Concrete Curb & Gutter Type CG-1 the quantity has been revised.
- 2. Item 38 Type 2 Preformed Marking Tape (Grooved), 6 in. White the quantity has been revised to include the 6" Crosswalk Lines, 6" Solid Lane Lines, and 6" Solid White Lines (Trail). All 6" lines shall be Type 2 Preformed Marking Tape (Grooved).

Job Special Provisions (JSP):

1. Revised JSP W Limestone Screenings as follows:

CALCIUM CHLORIDE

Calcium Chloride shall comply with the requirements of AASHTO M144, except the requirements for "Impurities Content" shall not apply. Supply Grade 2 in Type L (Liquid) form.

- Application rate shall be by pug mill alternately spreading and windrowing, or by multiple blade maintainers, by rotary tillers or other travelling plant mixers, or by other approved methods. and Application rate shall be at a rate of 10.0577 lbs/ton aggregate.
- 2. Calcium Chloride shall be sampled and tested in accordance with the applicable provisions of AASHTO T143.

Calcium Chloride furnished under this specification will be accepted upon receipt and approval of a certification prepared by the producer, which shall state that the materials meet the applicable specifications. Those specifications shall be listed by number, section reference, or other appropriate identification. The concentration of percentage of CaCl in the material supplied shall be included on the certification provided by the producer.
