

**INVITATION TO BID
FOR
US-54 SIDEWALK PROJECT
TAP-9900(529) & TAP-9900(563)
FOR THE CITY OF CAMDENTON, MO**

Please note that this project is a Re-Bid of the original project. The bidder must obtain the re-bid plans and specifications at City Hall as described below.

Sealed bids will be received at the office of the City Clerk, City Hall, City of Camdenton, Missouri until 10:00 AM local time on January 10th, 2017, for the US-54 Sidewalk Project, Camdenton, Missouri, after which they will publically be opened and read aloud.

The envelope containing the Bid must be sealed and addressed to the office of the City Clerk and clearly designated as **"US-54 SIDEWALK PROJECT"**.

The work will consist of construction of new sidewalk along US-54 from Cecil St. to Route 7. This includes numerous paved approaches, side street construction, curb ramps, grading, pedestrian signals, signing, and pavement marking.

Bid packages required for bidding purposes may be obtained from the office of the City Clerk, City Hall, 437 W. US Highway 54, City of Camdenton, Missouri, 65020. There is a \$35.00 (\$45.00 if mailed) non-refundable fee for each set of bid package (plans and specifications). To obtain a bid package, the bidder must provide all contact information requested on the Plan Holders List.

Bids must be submitted on the Proposal Form provided with the specifications and be accompanied by the Bidder's certified check or bid bond in the amount of five (5) percent of the bid. A performance bond will be required of the successful bidder. No bid may be withdrawn for a period of 90 days.

The Owner reserves the right to reject any and all bids. The project will be awarded to the lowest, responsive, responsible bidder.

Attention of bidders is called to the prevailing hourly rate of wages in the locality for each type of worker needed to execute the contract and also the general prevailing rate for legal holiday and overtime work, all as determined by the Division of Labor Standards. Section 290.250 RSMo.

The DBE goal for this project is 11%, total for both phases of the total federal project price.

Successful bidder shall comply with the provisions of Section 285.525 through 285.550 RSMo. Contract award is contingent on bidder providing an acceptable notarized affidavit stating that bidder is enrolled in, and participates in, a federal work authorization program with respect to the employees working in connection with the contracted service and further stating that the bidder does not knowingly employ any person who is an unauthorized alien in connection the contracted services.

Bidder shall submit completed Contractor Questionnaire and/or Contractor Prequalification Questionnaire with attachments not later than seven (7) days prior to the date and hour of the bid opening. See Secs 101-103 of the Standard Specifications, and Rule 7 CSR 10-15.900, "Prequalifications to Bid of Certain Contractors". Questionnaire and Contact information are provided on MoDOT's website.

Successful bidder shall comply with the provisions of Section 292.675 RSMo. Contract award is contingent on bidder providing an acceptable notarized affidavit stating that bidder and all

subcontractors doing work in connection with the contracted services has provided its on-site employees with a ten (10) hour course in construction safety and health approved by the Occupational Safety and Health Administration (OSHA) or a similar program approved by the Missouri Department of Labor and Industrial Relations.
