## **Project Specific Information**

- Traffic control (no complete closure)
- Grand Ave Bridge over 670 (MoDOT construction update)-MoDOT will reopen new bridge over 670 by December 1. City has temporary striping (paint) on a portion of Grand on both side of new bridge to match MoDOT's bridge striping. Contractor will remove the new temporary and replace with permanent marking.
- Submittals include Green paint on Grand; Electrical cables and signal heads
- Signal Head adjustment
- City will be willing to micro seal some of the locations, contractor will remove existing marking prior to micro application
- Grand Boulevard will receive paint for pavement marking due to condition of existing pavement. If resurfaced in early spring 2017, pavement marking could be changed to thermoplastic

- b) Bidder is required to deliver or fax to the Contract Administrator by 4:00 p.m. within three (3) business days after the bid opening the following documents:
- 1. DBE Submittal Forms (page 1 of 3; page 2 of 3; and page 3 of 3) (Form 00500.01)
- 2. Subcontractor Certification Regarding Affirmative Action (Prime Contractor must execute this Certification and obtain an executed Certification from each proposed subcontractor) (Form 00500.02)
- 3. Certification that Contractor is not Excluded from State or Federal Programs (Prime Contractor must execute this Certification and obtain an executed Certification from each proposed sub-contractor) (Form 00500.03)

DBE goal is 14%. See paragraph 24 of section 00210

In order execute the contract and issue a notice to proceed, contractor will need to have the appropriate bid required and DBE forms submitted in a timely manner. Contractor will also need to submit all subcontractor information to the City so that it can be submitted to MoDOT for approvals. # Signal Modification:

- -Signal sub-contractor should be an approved by KCMO
- -If a mast arm is cut at one end, it is responsibility of contractor to find a cap to match the cut end
- -Any removed signal head can be re-used upon approval from City

#### Contract Compliance:

- -This project has both Federal and City funding. Contractor is to pay its employees the higher wage rate of the two. Annual Wage Rate
- **-0830.03 Division of Labor Standards Rules & Regulations** are incorporated into and made part of this Contract. Heavy and Highway Construction rates to be followed.
- -Flaggers should be paid Labor pay; Sign workers should be paid Iron Worker rate

# **General comments:**

- -Some signals along Grand Boulevard need to be installed in concrete. Concrete should be subsidiary
- -Traffic control is based on # of Channelizers
- Contractors should be registered with City of KCMO prior to submitting bids
- -Contractors are required to acknowledge any/all addendums on their Bid Form
