

CONSTRUCTION OF AVA, MISSOURI SIDEWALK IMPROVEMENTS – PHASE IV

ADVERTISEMENT FOR BIDS

Sealed bid proposals endorsed "Proposal For Construction of Sidewalk Improvements – Phase IV, TAP-9900(879)", addressed to the City of Ava, P.O. Box 967, 127 SW 2nd Avenue, Ava, Missouri 65608, will be received by the City of Ava until **11:00 a.m., Prevailing Local Time, on Thursday, October 13, 2016** at the Ava City Hall, 127 SW 2nd Avenue, in Ava, Missouri and at that time will be publicly opened and read aloud.

The proposed work generally includes the construction of 5' wide sidewalk, access ramps, culverts, and any incidental work related thereto in accordance with the plans and specifications. The project is generally located along the State Highway Y corridor, particularly along NW 5th Avenue, NW 7th Street and NW 3rd Avenue, in the City of Ava, Douglas County, Missouri. The total length of the improvements is approximately 1,662 feet.

Plans and specifications may be obtained at the offices of Anderson Engineering, 2045 West Woodland, Springfield, Missouri for a fee of \$60.00 for each set. Additional shipping and handling expenses are applicable and the responsibility of the bidder. Digital plans and contract documents may be downloaded from the Engineer's website, www.andersonengineeringinc.com, for a fee of **\$20** by inputting Quest Project Number **4666840** on the website's Project Search page.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Ava hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition, including all revisions.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The project will be awarded to the lowest, responsive, responsible bidder.

The City of Ava reserves the right to reject any or all bids.

The DBE Goal for this project is 4%.

No 2nd tier subcontracting will be allowed on this project.
