

## **INVITATION TO BID**

and endorsed "Proposal" for constructing Project BRO-B045 (31), County Road 320, Howard County, Missouri, will be received by the Howard County Commission until 11:00 a.m., Standard Time, on February 18, 2020, at the office of the Howard County Commission, Howard County Courthouse, 108 One Courthouse Square, Fayette, MO 65248, and at that time will be publicly opened and read.

The proposed work includes:

Grading, construction of a 90' single span concrete I-girder bridge and a gravel surface 24 feet wide together with any incidental work on County Road 320 approximately 4.0 miles north of New Franklin on Highway 5, thence 1.25 miles west on County Road 320 over East Fork Sulphur Creek. The total length of the improvement is 850 feet.

Bids must be submitted on proposal blanks attached to the Specifications or copies of same and be accompanied by Bidder's Certified Check or Bid Bond in the amount of 5 percent of bid.

The prime contractor must have a fully responsive contractor questionnaire on file with the Missouri Highway and Transportation Commission at least seven (7) days prior to the bid opening date.

Payment for this work under this Contract will be made in cash and the Owner reserves the right to reject any and all bids or waive irregularities.

The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. When the Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962," (P.L. 87-581:76 Stat. 357) and implementing regulations.

OSHA Ten Hour Training Requirements: Missouri Law, 293.675 RSMO, requires any awarded contractor and its subcontractor(s) to provide a ten-hour Occupational and Safety and Health Administration (OSHA) Construction Safety Program (or a similar program approved by the Missouri Department of Labor and Industrial Relations as a qualified substitute) for their on-site employees.

The Howard County Commission hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

The project will be awarded to the lowest, responsive, responsible bidder.
