Sealed bids will be received for the Lakeview/Morris Street Curb & Gutter Project STP – 4400 (308) at the office of the Public Works Department, for the City of Mexico, Missouri until 2 P.M. local time on the 10th day of August , 2016, at City Hall, 300 North Coal Street, Mexico, Missouri 65265, at which time and place all bids will be publicly opened and read aloud. All bids shall be submitted in the form of a hard copy.

The project consists of the construction of curb and gutter on the east side of Morris St from Liberty to Monroe, overlay of the same stretch of Morris, and construction of curb and gutter on Lakeview beginning at Fairgrounds St.

All equipment, materials and workmanship must be in accordance with the drawings and specifications on file with the City Clerk, Mexico, Missouri and in the office of Public Works.

Prospective bidders desiring the Contract Documents for use in preparing bids shall obtain a set of such documents from American Document Solutions 1400 Forum Boulevard, Suite 1C, Columbia, Missouri 65203, telephone number 573.446.7768, at a nonrefundable fee of \$50 per printed set.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the State of Missouri Division of Labor Standards.

The City of Mexico hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT’s Qualified Contractor List per section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects must provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier’s check or a bid bond in the amount of 5% shall be submitted with each proposal.

All forms with foot marked as “BID FORM” shall be submitted with each proposal.

No Bidder may withdraw his bid for a period of 60 days after the date of opening bids.

A Disadvantage Business Enterprise (DBE) goal of **8%** has been established for this project.

The contract, if awarded, will be awarded to the lowest, responsive, responsible bidder complying with the Conditions of the Contract Documents within the Owner’s budget. The Bidder to whom the awards are made will be notified at the earliest possible date. The Owner, however, reserves the right to reject any and all Bids and to waive any informality in Bids received whenever such rejection or waiver is in his interest.
