Separate sealed bids for the Hubble Creek Recreation Trail Project – Phase II, to serve the City of Jackson will be received by the City Administrator at City Hall, until, 10:00 A.M. on June 8, 2016 and then at said office publicly opened and read aloud.

The project shall consist of: Construction of an eight (8) foot wide walking trail along Hubble Creek from the Jackson City Park up to the newly constructed Jackson Civic Center; also includes 5 foot wide sidewalks and lighting along entire length of trail.

The envelopes containing the bids must be sealed, addressed, and designated as bids for the Hubble Creek Recreation Trail Project - Phase II; Attn: City Administrator.

The DBE (Disadvantaged Business Enterprise) contract goal for the amount of work to be awarded for the Hubble Creek Trail – Phase II project is 6% of the total federal project price. The bidder shall also complete the DBE Identification Submittal forms for the project in accordance with the General Provisions. Missouri Law, 292.675 RSMO, requires any awarded contractor and its subcontractor(s) to provide a ten-hour Occupational Safety and Health Administration (OSHA) Construction Safety Program for their on-site employees.

The Owner must award the project to the lowest responsive, responsible bidder. All bidders are required to use the pre-qualification process outlined by MoDOT. See the Missouri Standard Specifications for Highway Construction, Section 102 for additional information. Each Bidder must deposit with his bid, security in the amount, form, and subject to the conditions provided in the Information for Bidders. No Bidder may withdraw his bid within 60 days after the actual date of the bid opening.

The City of Jackson hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry or national origin in consideration for an award.
