An endorsed "Proposal" for constructing Independence & Gordonville Roundabout, will be received by the City until **10:00 AM (prevailing local time) on May 3, 2016**, at the Office of the City Engineer, City Hall, 401 Independence, Cape Girardeau, Missouri 63703, and at that time will be publicly opened and read.

The project consists of furnishing all labor, tools, equipment and materials for construction of a new single lane roundabout intersection including removal of improvements, excavation and embankment construction, new driveways, stormwater structures and piping, retaining walls, striping and signage, restoration of adjacent grades, seeding and mulching and any other associated items to complete the project in accordance with the plans and specifications prepared by Koehler Engineering and Land Surveying, Inc.

The contract provides for the furnishing of all labor, equipment, and materials necessary for the improvement and construction required per the improvement plans, specifications and construction documents.

Sealed Proposals should be clearly marked "Proposal for Independence & Gordonville Roundabout".

All bidders are required to purchase plans and specifications to submit a bid for this project. Proposals will be publically opened and read aloud on **May 3, 2016, at 10:00 AM (prevailing local time)** in the Development Services Conference Room, City Hall, 401 Independence Street, Cape Girardeau, MO 63703.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

A mandatory pre-bid conference will be held at **10:00 AM (prevailing local time)** on the **20<sup>th</sup>** day of **April**, at Shawnee Park Center at 835 West End Blvd, Cape Girardeau. Representatives of the Owner and Engineer will be present to discuss the project. **All bidders are required to attend and participate in the pre-bid conference.** The Engineer will transmit to all prospective Bidders of record such Addenda as Engineer considers necessary in response to questions arising at the conference. Oral statements may not be relied upon and will not be binding or legally effective.

The City of Cape Girardeau hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. **A DBE goal of 11% has been established for this project. Only the Work performed by DBE subcontractors that appear on MODOT's approved listing at the time of bid opening will be applied towards calculating the DBE goal.**

The prime contractor must go through MoDOT pre-qualification process and be on the MoDOT approved contractor listing. The prime contractor must have a fully responsive contractor questionnaire on file with the Missouri Highways and Transportation Commission (MHTC) at least seven (7) days prior to the date and hour of the bid opening (See Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011). The prime contractor on a project must perform, with its own staff, contract work amounting to NOT less than 30% of the total original contract price.

The project will be awarded to the lowest, responsive, responsible bidder. The Owner reserves the right to waive all informalities, with MoDOT concurrence, not involving price, time or changes in work and to negotiate contract terms

with the Successful Bidder.

Plans, specifications, proposal form, and contract for said improvement may be reviewed and/or obtained in the Engineer's Office of the City of Cape Girardeau, 401 Independence, Cape Girardeau, Missouri, 63703. A **non-refundable** fee of \$ **100.00** per set is required.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

Pursuant to 285.530 R.S. Mo, the bidder must affirm its enrollment and participation in a federal work authorization program with respect to the employees proposed to work in connection with the services requested herein by including with the bid proposal 1) submitting a completed, notarized copy of AFFIDAVIT OF WORK AUTHORIZATION and 2) providing documentation affirming the bidder's enrollment and participation in a federal work authorization program with respect to the employees proposed to work in connection with the services requested herein.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

The right is reserved to reject any or all bids by the City of Cape Girardeau with MoDOT concurrence.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
