1.5 REVISIONS TO ADDENDUM #1

A. On ADDENDUM #1 Section 1.7 A 11) regarding "JSP "19" CLASS A EXCAVATION AND EMBANKMENT IN PLACE" Please **DELETE** the comment in

the second sentence regarding the volume of Embankment in Place that must be hauled in and **REPLACE** with the following:

The 8,300 CY reflects the total compacted volume of embankment necessary for bringing the grades up to the elevations indicated in the Basis of Bids for Embankment-in-Place (bid item #9). For bidding purposes, it should be safe to assume that the Class A volume (less up to 500 CY for shrinkage and/or unsuitable material) can be used on site and can be deducted from the Embankment-in-Place volume to obtain the approximate compacted volume of borrow that will need to be hauled in from off site.

B. Question; -- "There are several short segments of 36" RCP...can we bid triple wall polypropylene pipe on these...?"

<u>Answer; --</u> City of Cape Girardeau Standard Specifications Section 1001.2C allows the substitution of Polypropylene (HDPP) pipe for RCP storm pipes up to 18" diameter for locations that are not located under the street pavement. Substitution of HDPP for RPC pipe that is larger than 18" diameter is not presently allowed.
