

INVITATION TO BID

Lincoln County Bridge Replacement

Sealed bids for Lincoln County Bridge Replacement,
will be received at: Lincoln County Courthouse, 201 Main St., Troy, MO 63379
until 11:00 a.m. on the 19th day of April, 2016, at the office of the Lincoln County Commission,
and at that time will be publicly opened and read. All bids shall be submitted in the form of a hard copy.

The proposed work includes the construction of a 52ft long, single span Precast Concrete Beam bridge on 3.5% grade to replace the existing structure on Fred Norton Road over Branch of Coon Creek, Lincoln County, Missouri.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations State Wage Rates.

The Lincoln County Commission hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The contract, if awarded, will be awarded to the lowest, responsive, responsible bidder complying with the Conditions of the Contract Documents within the Owner's budget. The Bidder to whom the awards are made will be notified at the earliest possible date. The Owner, however, reserves the right to reject any and all Bids and to waive any informality in Bids received whenever such rejection or waiver is in his interest.
