### Gentlemen:

This Addendum is hereby made a part of the Contract Documents to the same extent as if it were originally included herein. This Addendum shall be inserted in the Contract Documents and submitted with the Bid, and includes the following items:

# CONTRACT DOCUMENTS:

- 1) The bid schedule is hereby replaced with the attached revised bid schedule. Revision was made to the Seeding & Mulch quantity.
- Job Special Provision #3, '<u>Inspection and Acceptance Testing</u>', Delete "at the contractor's expense." Testing will be conducted by the consultant and paid for by the Lawrence County Commission as outlined in their existing engineering services agreement. Acceptance testing will <u>NOT</u> be conducted at the contractor's expense.

### **GENERAL INFORMATION:**

- 1) The City of Mount Vernon will provide the contractor a place within the city limits to dispose of debris from removals of existing improvements.
- 2) All existing curbing to be removed as shown on the plans. Any removals necessary to complete the project but not quantified in the removal of improvements pay item, shall be considered incidental to the project.

### PLANS:

- 1) Quantity for Seeding & Mulch on Sheet 2A & Sheet 2B of the plans shall hereby be revised to 0.27 AC.
- 2) Sheet 10 of the plans erroneously notates the post height at 14'-0" under the Street Light Pole Specifications. The correct post height is 16'-0" as dimensioned in the detail.
- 3) Sheet 10 of the plans erroneously states that the refractor shall be designed for an IES type V distribution. Refractor shall be designed for an IES type III distribution.
