

## INVITATION TO BID

Sealed bids for the Greentrails Drive South project 2013-PW-06, Federal Project STP-5410(619) will be received at Chesterfield City Hall (690 Chesterfield Parkway West, Chesterfield, MO 63017) until 10:00 am (prevailing local time) on the 6<sup>th</sup> day of April, 2016 and at that time will be publicly opened and read. All bids shall be submitted in paper form.

The proposed work includes the removal and replacement of approximately 19,130 square yards of pavement, 8,768 lineal feet of curb on Greentrails Drive South between White Road and Ladue Road with 7-inch Portland cement concrete (PCC) pavement with a 6" mountable curb, over 4-inches of Type 5 Aggregate over a geotextile layer on a prepared subgrade. Work will also include removal and replacement of existing 4' wide sidewalk with 5' wide sidewalk, as well as storm sewers, underdrains, expansion joints, striping, restoration, traffic control, paved approaches and driveway extensions, curb ramps, and all other necessary and incidental work to make for a complete and usable roadway. Staged construction will be required to maintain traffic on Greentrails Drive South during the construction of this project.

When downloading or picking up a bid packets, you will be required to provide your name and company information on a bidder's list record and furnish an email address for receiving official bidding communications and addenda. No oral interpretation will be recognized.

A pre-bid conference will be held at 10:00 am on the 23 day of March, 2016, at Chesterfield City Hall. **All bidders are encouraged to attend the pre-bid meeting.**

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Chesterfield hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, business owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Chesterfield reserves the right to reject any or all bids.

The DBE goal for this project is 15% with one trainee.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
