All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening. Submit All E-Verify Information.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees with sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

A DBE goal of <u>Eight (8%)</u> percent has been established for this project. All DBE's must be certified and be listed in either the MoDOT DBE Directory or the MRCC DBE Directory. <u>Contractor must include Page DBE 7.1 and declare DBE percentage in Bid package.</u>

The City of Campbell reserves the right to reject any or all bids.

No second tier subcontracting will be allowed on this project.

The prime contractor must perform with his own forces at least 30 percent of the total contract amount.

MoDOT and FHWA may make inspections of the work and that the contractor shall grant them access to all parts of the work. Representatives of MoDOT will make a final inspection on all projects, preferably at the same time as the local agency makes final inspection.

The engineer's technicians who perform, or are required by the FHWA to witness, such sampling and testing shall be deemed as qualified by virtue of successfully completing the requirements of EPG 106.18 Technician Certification Program, for that specific technical area.
