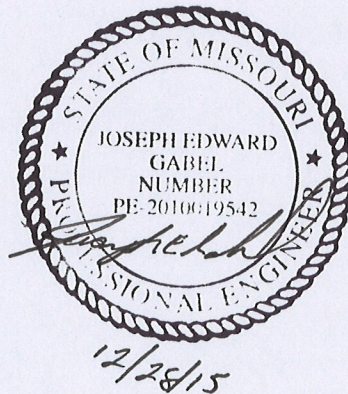

Sealed bids for the construction of the **RIVER BEAUTIFICATION - HIKING TRAIL** will be received by the City Clerk of Ste. Genevieve at the City Hall, 165 S. Fourth St., Ste. Genevieve, MO 63670 until **2:00 PM on Thursday January 14, 2016** and at that time will be publicly opened and read aloud. A pre-bid meeting will be held at the City of Ste. Genevieve on **Tuesday, January 5, 2015 at 2:00 PM.**

The project includes: Construction of 5,114 LF of 5' wide asphalt hiking/biking trail, 1,757 LF of 5' wide concrete hiking trail with a 4" wide pavement stripe separating the edge of pavement and the hiking trail. 785 SF of Concrete driveway entrance and 3,969 SF of asphalt driveway entrances along the trail will be replaced. One 5'x6' and one 4'x 4' open back box inlet, one 4'x3' grate inlet will be constructed. Various lengths of 15" RCP and 18" and 24" CMP and 18" HDPE will be installed as part of the storm sewer improvements along the hiking trail.

Missouri law, 292.675 RSMO, requires the awarded contractor and its subcontractor(s) to provide a ten-hour occupational safety and health administration (OSHA) construction safety program (or a similar program approved by the Missouri department of labor and industrial relations as a qualified substitute) for their on-site employees (laborers, workmen, drivers, equipment operators, and craftsmen) who have not previously completed such a program and are directly engaged in actual construction of the improvement (or working at a nearby or adjacent facility used for construction of the improvement). The awarded contractor and its subcontractor(s) shall require all such employees to complete this ten-hour program, pursuant to 292.675 RSMO, unless they hold documentation on their prior completion of said program. Penalties for non-compliance include contractor forfeiture to the City of Ste. Genevieve, Missouri in the amount of \$2,500.00, plus \$100 per contractor and subcontractor employee for each calendar day such employee is employed beyond the elapsed time period for required program completion under 292.675 RSMO.

The BIDDER shall comply with the Disadvantaged Business Enterprise (DBE) Contract Provisions. The goal for the **River Beautification - Hiking Trail** is **5.00%**.

The City of Ste. Genevieve, MO hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

If a contract award is made, it will be made to the lowest, responsive, responsible bidder. This is a prevailing wage project. State and Federal wage rates will be used for this project, the higher of the two for each job classification should be used.
