An endorsed "Proposal" for the rehabilitation of Old Bonhomme Road between Olive Boulevard and North Price Road, St. Louis County, Olivette, Missouri, will be received by the City of Olivette until 10:00 A.M. (prevailing local time) on January 14, 2016 at Olivette City Hall, 9473 Olive Boulevard, Olivette, Missouri 63132, and at that time will be opened and publicly read.

The proposed work includes:

All work and materials including grading and constructing pavement rehabilitation, new concrete curb and gutter, new sidewalks, new storm sewers, and new retaining walls. The project is located on Old Bonhomme Road between Olive Boulevard and North Price Road in St. Louis County, Olivette, Missouri.

State and federal wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal.

The prime contractor must be on MoDOT's approved contractor listing. This requirement includes that the contractor has submitted to MoDOT a Contractor Questionnaire and/or Contractor Prequalification Questionnaire with attachments not later than seven (7) days prior to the date and hour of the bid opening (see Section 102.2 of the *Missouri Standard Specifications for Highway Construction* for more details). The prime contractor must perform, with its own organization, work amount to not less than 30% of the total original contract price.

The City of Olivette hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award. **A DBE goal of 12%** has been established for this project. Only work performed by DBE subcontractors that appear on MoDOT's approved listing at the time of bid opening will be applied towards calculating the DBE goal.

Contractors and subcontractors who sign a contract to work on public works project must provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

Bid packages are available and may be obtained from the Fenton office of Cochran located at 737 Rudder Road, Fenton, MO 63026 between the hours of 7:30 a.m. and 4:00 p.m., Monday through Friday, upon payment of a non-refundable fee of \$100.00 per set. The character and amount of security to be furnished by bidders is stated in the contract documents mentioned above.

The project contract will be awarded to the lowest, responsive, responsible bidder.
