

REQUEST FOR BIDS/INVITATION FOR BIDS

Skyhaven Airport Warrensburg, Missouri State Block Grant Project No. 14-019A-1

Sealed bids will be received until 2:00 p.m. CDST, Thursday, September 10, 2015, and then publicly opened and read by the University of Central Missouri at Procurement Office Conference Room 113, Building A, for furnishing all labor, materials and equipment and performing all work necessary for:

Schedule I - Grading Improvements

Schedule II - Tree Clearing

Contract Documents. The complete set of Specifications and Contract Documents can be downloaded from the University of Central Missouri's bid site (<http://www.ucmo.edu/procurement/invite.cfm>), beginning on August 19, 2015. In order to submit a responsive bid as a Prime Contractor and to receive all necessary addendum(s) for this project, you must be on the Planholder's List. To view all planholder documents (contract documents, plans and addendums) you must fill out the online form located at (<http://www.ucmo.edu/surveys/?formID=2343>). By filling out and submitting this form, you agree to be publicly listed on the bid site with your contact information as a planholder for all projects requested. It is the planholder's responsibility to review the site for addendums and changes before submitting their proposal.

***Note:** Plan ahead when submitting the online request form and allow up to 2 business days for approval and access to projects.

Pre-Bid Conference. The pre-bid conference for this project will be held on Wednesday, September 2, 2015 at 10:00 a.m., at Procurement Office Conference Room 113, Building A. All bidders are required to examine the site to become familiar with all site conditions.

Each proposal must be accompanied by a bid guaranty in the amount of five (5) percent of the total amount of the bid. The bid guaranty may be by bid bond made payable to University of Central Missouri.

Bids may be held by University of Central Missouri for a period not to exceed 60 calendar days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The right is reserved, as University of Central Missouri may require, to reject any and all bids and to waive any informality in the bids received.

Construction for this project is expected to take 60 calendar day(s).

In accordance with the Davis-Bacon Act, and the Missouri Prevailing Wage Law, the Contractor will be required to comply with the wage and labor requirements and to pay minimum wages in accordance with the schedule of wage rates established by the United States Department of Labor and the Missouri Division of Labor Standards, respectively. The highest rate between the two (Federal and State) for each job classification shall be considered the prevailing wage.

The University of Central Missouri, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

This project is subject to the requirements of 49 CFR Part 26 Disadvantaged Business Enterprise Participation. The owner has established a contract goal of 10 percent participation for small business concerns owned and controlled by qualified disadvantaged business enterprises (DBE). The bidder shall make and document good faith efforts, as defined in Appendix A of 49 CFR Part 26, to meet the established goal.

A certification of Nonsegregated Facilities, in accordance with 41 CFR Part 60, must be submitted prior to the award of a federally-assisted construction contract exceeding \$10,000 which is not exempt from the provisions of the Equal Opportunity Clause.

Contractors receiving federally assisted construction contract awards exceeding \$10,000, which are not exempt from the provisions of the Equal Opportunity Clause will be required to provide for the forwarding of the notice to prospective subcontractors for supplies and construction contracts where the subcontracts exceed \$10,000 and are not exempt from the provisions of the Equal Opportunity Clause. The penalty for making false statements in offers is prescribed in 18 U.S.C. 1001.
