The following revisions and/or additions shall be referred to as part of the Bid/Contract Documents.

General Clarifications:

1. **Period of Performance**
Clarification: Per MoDOT requirements, Notice To Proceed is to be given within 120 days of MoDOT's approval of the signed contract between the Contractor and the City. However, if the Notice to Proceed occurs between December 15 and April 30, actual construction need not begin until Working Days are in effect.
2. **Itemized Bid Item 38 – Pipe Rail Fence**
Clarification: Pipe Rail Fence, bid item 38. The Pipe Rail Fence is a safety fence used on top of or behind a retaining wall on the Hinsdale East portion of the trail. Tech Spec TS-7 applies to this. Detail A, located on sheet 19, is incorrect and does not apply to bid item 38.
3. Federal Wage Order remains the same as posted in the RFQ MO150001.
4. No other changes
