Pre-Bid Conference. The pre-bid conference for this project will be held on Monday, August 10, 2015 at 11:00 a.m., at the Airport Terminal. All bidders are required to examine the site to become familiar with all site conditions.

Bid Conditions. The bidder is required to provide all information as required within the Contract Documents. The bidder is required to bid on all items of every schedule or as otherwise detailed in the Instructions to Bidders.

Each proposal must be accompanied by a bid guaranty in the amount of five (5) percent of the total amount of the bid. The bid guaranty may be by bid bond made payable to City of West Plains.

Bids may be held by City of West Plains for a period not to exceed 90 days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The right is reserved, as City of West Plains may require, to reject any and all bids and to waive any informality in the bids received.

Construction for this project is expected to take 14 Calendar Day(s).

In accordance with the Davis-Bacon Act, and the Missouri Prevailing Wage Law, the Contractor will be required to comply with the wage and labor requirements and to pay minimum wages in

50 accordance with the schedule of wage rates established by the United States Department of Labor
51 and the Missouri Division of Labor Standards, respectively. The highest rate between the two
52 (Federal and State) for each job classification shall be considered the prevailing wage.

54 The City of West Plains, in accordance with the provisions of Title VI of the Civil Rights Act of
55 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders
56 that it will affirmatively ensure that any contract entered into pursuant to this advertisement,
57 disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in
58 response to this invitation and will not be discriminated against on the grounds of race, color, or
59 national origin in consideration for an award.

61 This project is subject to the requirements of 49 CFR Part 26 Disadvantaged Business Enterprise
62 Participation. The owner has established a contract goal of 7.0 percent participation for small
63 business concerns owned and controlled by qualified disadvantaged business enterprises (DBE).
64 The bidder shall make and document good faith efforts, as defined in Appendix A of 49 CFR Part
65 26, to meet the established goal.

67 A certification of Nonsegregated Facilities, in accordance with 41 CFR Part 60, must be submitted
68 prior to the award of a federally-assisted construction contract exceeding \$10,000 which is not
69 exempt from the provisions of the Equal Opportunity Clause.

71 Contractors receiving federally assisted construction contract awards exceeding \$10,000, which are
72 not exempt from the provisions of the Equal Opportunity Clause will be required to provide for the
73 forwarding of the notice to prospective subcontractors for supplies and construction contracts
74 where the subcontracts exceed \$10,000 and are not exempt from the provisions of the Equal
75 Opportunity Clause. The penalty for making false statements in offers is prescribed in 18 U.S.C.
