**Pre-Bid Conference.** The pre-bid conference for this project will be held on Tuesday, May 12, 2015 at 11:00 a.m., at 6079 County Road 425, Hannibal, MO 63401 - Airport Conference Room. All bidders are required to examine the site to become familiar with all site conditions.

**Bid Conditions.** The bidder is required to provide all information as required within the Contract Documents. The bidder is required to bid on all items of every schedule or as otherwise detailed in the Instructions to Bidders.

Each proposal must be accompanied by a bid guaranty in the amount of five (5) percent of the total amount of the bid. The bid guaranty may be by bid bond made payable to City of Hannibal.

Bids may be held by City of Hannibal for a period not to exceed 90 calendar days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The right is reserved, as City of Hannibal may require, to reject any and all bids and to waive any informality in the bids received.

Construction for this project is expected to take 45 Calendar Day(s).

In accordance with the Davis-Bacon Act, and the Missouri Prevailing Wage Law, the Contractor will be required to comply with the wage and labor requirements and to pay minimum wages in

51 accordance with the schedule of wage rates established by the United States Department of Labor  
52 and the Missouri Division of Labor Standards, respectively. The highest rate between the two  
53 (Federal and State) for each job classification shall be considered the prevailing wage.

55 The City of Hannibal, in accordance with the provisions of Title VI of the Civil Rights Act of 1964  
56 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders that it  
57 will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged  
58 business enterprises will be afforded full and fair opportunity to submit bids in response to this  
59 invitation and will not be discriminated against on the grounds of race, color, or national origin in  
60 consideration for an award.

62 This project is subject to the requirements of 49 CFR Part 26 Disadvantaged Business Enterprise  
63 Participation. The owner has established a contract goal of 6.0 percent participation for small  
64 business concerns owned and controlled by qualified disadvantaged business enterprises (DBE).  
65 The bidder shall make and document good faith efforts, as defined in Appendix A of 49 CFR Part  
66 26, to meet the established goal.  
67

68 A certification of Nonsegregated Facilities, in accordance with 41 CFR Part 60, must be submitted  
69 prior to the award of a federally-assisted construction contract exceeding \$10,000 which is not  
70 exempt from the provisions of the Equal Opportunity Clause.

72 Contractors receiving federally assisted construction contract awards exceeding \$10,000, which are  
73 not exempt from the provisions of the Equal Opportunity Clause will be required to provide for the  
74 forwarding of the notice to prospective subcontractors for supplies and construction contracts  
75 where the subcontracts exceed \$10,000 and are not exempt from the provisions of the Equal  
76 Opportunity Clause. The penalty for making false statements in offers is prescribed in 18 U.S.C.
