(1) **PROPOSED WORK:** The proposed work, hereinafter called the work, includes:

This project shall include approximately 35,000 square yards of cold milling and asphalt overlay with replacement of handicap accessible curb ramps at all intersecting streets with ADA compliant ramps and associated miscellaneous curb and gutter repairs
