Sealed bids for Wentzville Parkway Turnlane Project STP-7304(603) will be received at: City Hall, 310 W Pearce Blvd, Wentzville, MO 63385 until 2:00 o'clock P.M. (Prevailing Local Time) on the 27<sup>th</sup> day of March 2015, at the Wentzville City Hall, and at that time will be publicly opened and read. All bids shall be submitted in the form of Sealed Bid. Bids must be submitted in a sealed envelope, and must be clearly marked on the outside of the envelope with the following:

The proposed work includes: Installation of new pavement, ADA Sidewalks and Trail, Storm Sewers, Sanitary Sewer and Water Adjustments, Lighting and Signal Upgrades

Plans and specifications may be purchased from the Wentzville City Hall at 310 West Pearce Blvd. Wentzville, MO 63385.

A pre-bid conference will be held at 2:00 PM on the 16 day of March, at Wentzville City Hall at 310 West Pearce Blvd. Wentzville, MO 63385. **All bidders are encouraged to attend the pre-bid meeting.**

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Wentzville hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.”

All bidders must be on MoDOT’s Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier’s check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Wentzville reserves the right to reject any or all bids.

The DBE Goal for this project is 14%.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
