The City Clerk, or designated representative, of the City of Grandview, Missouri, will receive sealed bids for the **MAIN STREET PHASE VII / HIGHGROVE ROAD** until 10:00 A.M., on the 24th day of March, 2015, at the Municipal Services Building, 1200 Main Street, Grandview, Missouri 64030, at which time all bids received will be publicly opened and read aloud.

The contract provides for: Cold milling and asphalt overlay of approximately 38,374 square yards of roadway, 9,930 linear feet of curb and gutter replacement, 4,364 square feet of sidewalk, replacement of 38 ADA ramps, modification of two traffic signals, and 259 square yards of driveway approaches.

Interpretations will be made only by addendum, duly issued, and one copy of such addendum will be Emailed to each party who has received sets of these contract documents for the purpose of bidding. Because of the time required to publish and deliver, no interpretative addendum will be issued within the last five (5) days before the bid date.

This advertisement is for qualified contractors, experienced in the construction of public improvements. Bids from construction managers that intend to hire the construction of the project, will not be considered as responsive to the proposal. The successful bidder will be required to provide proof of either ownership or lease of equipment that will be utilized to construct this project.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher. The project is subject to the requirements of RSMo 292.675 concerning worker safety. Pursuant to RSMo 285.530 bidders are required to submit, or have on file with the City of Grandview, the Worker Eligibility Verification affidavit within the contract documents.

The City of Grandview hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per section 102.2 of the Missouri Standard Specification for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening. DBE Sub-Contractors must be on the MRCC DBE Listing prior to bidding. A certified or cashier's check of a bid bond in the amount of 5% shall be submitted with each proposal.

The DBE goal for the project is 12%. No 2<sup>nd</sup> tier subcontracting will be allowed on this project.

**The project will be awarded to the lowest, responsive, responsible bidder. The City of Grandview reserves the right to reject any and all bids; and to waive irregularities or informalities in any bid submitted. Bids received after the specified time of closing will be returned unopened.**
