

## NOTICE TO CONTRACTORS

### Notice No. 2624

Sealed bids for Republic Road Widening Phase 2 ACNHPP-S600(40) will be accepted at the City of Springfield, Busch Building, 840 Boonville, Springfield, MO 65802 until 10:00 AM on February 24, 2015 and then publicly opened and read aloud in the 2<sup>nd</sup> floor East Conference room of the Busch Building. Bids received after 10:00 a.m. will be returned unopened.

This project consists of reconstructing approximately 2,100 feet of Republic Road to five lanes from Kansas Court to west of Parkcrest Avenue. This work includes widening Bridge No A41841, 927 cubic yards of excavation, 14,852 cubic yards of embankment, 1,020 linear feet of curb and gutter, 24,391 square feet of sidewalk, 408 linear feet of 18-inch storm pipe, 770 square feet of retaining wall, 1,325 linear feet of guardrail, 440,470 pounds of structural plate girder, 1,853 square yards of slab on steel, 296 square yards of modified bridge approach slab, and 1547 linear feet of 2" conduit for whiteway lighting.

A certified or cashier's check or bid bond in the amount of 5 percent of the bid shall be submitted with each proposal. A Performance Bond on the City's standard forms for the full amount of the contract will be required of the successful Bidder. A Labor and Materials Payment Bond on the City's standard forms for the full amount of the contract will be required of the successful Bidder. The Bidder shall submit a list of subcontractors as specified in the bid documents with its bid.

Note all labor shall be paid Missouri Prevailing Wages and/or Federal Davis-Bacon Wages, whichever is higher for each job classification used.

The project will be awarded to the lowest, responsive, responsible bidder. The successful Bidder shall comply with certain insurance requirements as specified in the bid documents. The city reserves the rights to reject any and all bids and to waive irregularities in bids.


Bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions.

DBE goal for this project will be 9.0 percent.

Second tier subcontracting will not be permitted on this project.
