- See a new JSP #33 for the painting of the signal posts. This will apply to the existing signal mast arms and posts at Bryan Road and Veteran's Memorial Parkway.

5. Add Alternates

1.0 Description. This contract requires bidders to bid on additional contract work that will be considered for award. The award of this project does not guarantee work for all add alternate sections.

Routes	Proposal Section Description
Bryan Road	Base – Work includes roadway paving, sidewalk, pavement marking, signals, curb and gutter.
Bryan Road	Add Alternate 1 – using a 4 (four) hour high early concrete mix instead of the base bid concrete mix. This price should be an upcharge from the base bid line item representing the same line item. It will be simply added onto the contract as is if selected.
Bryan Road	Add Alternate 2 - Field paint the existing signal posts and mast arms at the intersection of Bryan Road and Veteran's Memorial Parkway.

Note: See plans for a breakdown of all quantities for each add alternate section.

2.0 Consideration of Bids. The contractor shall submit a bid for each add alternate section. The City reserves the right to award, to the lowest responsible bidder, the combination of base plus add alternate sections that will allow the most work to be completed within the City's budget of \$210,000. If the City chooses to exercise this right, the award of add alternate sections will be selected in accordance with the following priorities:

1. Base
2. Base + Add Alt 2
3. Base + Add Alt 2 + Add Alt 1

2.1 The City reserves the right to award the combination of highest priority add alternate sections over the City's budget as long as the low bidder does not change and the award of the combination of highest priority alternate sections does not exceed more than ten percent or \$250,000 of the City's budget, whichever is less.

2.2 The City's budget is the basis for award the base section. The base section of the contract will be awarded or rejected in accordance with Sec 100.

2.3 The awarded bidder will be notified, of the City's selection of the combination of add alternate sections to be awarded.

3.0 Bid Bond Requirements. The contractor shall be required to obtain a bid bond for 5% of the total bid amount for the base bid and all add alternates. This bid bond will be considered applicable to the proposed work for any option.

4.0 DBE Goal. The DBE contract goal percentage specified in the Request for Bid applies to work completed for the base bid and all add alternates. The DBE contract goal percentage will be considered applicable to the proposed work for any add alternate section that is awarded.

4.1 The bidder shall submit the completed “DBE Identification Submittal” information in accordance with the bid documents for the total DBE participation percentage for the base bid and all add alternates.

4.2 If the contract is awarded for less than the maximum total of all add alternates, the awarded bidder shall submit a modified “DBE Identification Submittal” form for the proportionately reduced work with the executed contract documents after award. The modified “DBE Identification Submittal” form shall specify the DBE firm(s) to be used to meet the DBE participation percentage identified in the bid submittal for the proportionately reduced work of the awarded add alternates.

4.2.1 With submittal of the modified “DBE Identification Submittal” form, the awarded bidder is not allowed to eliminate any DBE firm(s) previously identified to complete items of work for the awarded add alternates. The awarded bidder is only allowed to proportionately reduce the participation of previously identified DBE firm(s) on awarded add alternates or eliminate previously identified DBE firms for add alternates that were not awarded.

4.2.2 The failure of the awarded bidder to submit the modified “DBE Identification Submittal”, listing actual, committed DBE participation percentage equal to or greater than the DBE participation percentage specified in the bid for all add alternates, may result in the bid being declared non responsive and may result in forfeiture of the bid surety bond or bid guaranty from the bidder.

5.0 Basis of Payment. The accepted quantities of the chosen combination of base plus add alternate sections will be paid for by the contract unit bid price for item numbers found within the schedule of items for each section.

33. PAINTING SIGNAL POSTS, LIGHTING POSTS AND SIGN POSTS

1.0 Steel signal posts, mast arms, and sign posts shall be galvanized after fabrication in accordance with AASHTO M111. They shall then be painted in accordance with the following provision.

2.0 Precautions shall be taken with the galvanizer to ensure that the galvanized materials are not water or chromate after galvanizing. Surfaces to be painted shall be prepared in accordance with ASTM D-6386 "Standard Practice for Preparation of Zinc (Hot-Dip Galvanized) Coated Iron and Steel Product and hardware Surface for Painting" using the method for "partially weathered galvanized steel". This includes checking for the presence of a chromate conversion coating or wet storage stain and removing if necessary, smoothing the surface, removing any oil or grease, and priming with one coat (1-2 mils) of a penetrating epoxy sealer meeting the requirements of MSP-96-07C. Surfaces shall then be given two coats (2 mils minimum each) of a System G (black) matching Federal Standard 595B 17038 polyurethane finish coat. Primer and finish coat shall be products from the same manufacturer and used in accordance with the manufacturer's instructions.

3.0 The contractor shall submit to the engineer a detailed painting plan, including product data sheets and finish color sample, prior to the work.

4.0 Payment for painting signal posts and appurtenances above the base plate including the exposed bolts, completely in place, including all materials, equipment, tools, labor and work incidental thereto, shall be considered to be completely covered by the contract unit bid for item No. 902-99.02, Painting Signal Posts, per lump sum.

4.01 Payment for painting sign posts above the concrete footing including break away assemblies, sign brackets, completely in place, including all materials, equipment, tools, labor and work incidental thereto, shall be considered to be completely covered by the contract unit bid for item No. 902-99.02, Painting Sign Posts, per each.

4.02 Payment for painting lighting posts including the transformer base, bracket arm and luminaire head/hood completely in place, including all materials, equipment, tools, labor and work incidental thereto, shall be considered to be completely covered by the contract unit bid for item No. 902-99.02, Painting Lighting Posts, per each.
