Sealed bids for the "Proposal for the Construction of Appleton City Sidewalk Improvements STP 3315 (406)" will be received at: Appleton City Hall, 114 East 4th, PO Box 134, Appleton City, MO 64724 until 10:00 o'clock A.M.(Prevailing Local Time) on the 8th day of January, 2015, at the office of the Appleton City City Hall 114 East 4th Street, Appleton City, MO 64724, and at that time will be publicly opened and read. All bids shall be submitted as a Hard Copy.

The proposed work includes:

The demolition removal, and construction of new concrete sidewalks along the north and south side of Highway 52/ 4th Street from Advent St. to Chestnut St. approximately 2,900 lineal feet to include, but not limited to, concrete sidewalk, driveway replacements, curb ramps, curb and gutter, asphalt, trench drains, ADA ramps and handrail to buildings, street light foundations and pvc sleeves, and any work considered incidental in accordance with the plans and specifications.

Plans and specifications may be purchased at the office of the Great River Engineering (GRE), at 2826 S. Ingram Mill, Springfield, MO 65804 upon payment of \$75.00, which is not refundable. All bidders must purchase plans through Great River Engineering, Inc. and be on the plan holder list in order to bid the project. A pre-bid conference will be held at 10:00 A.M. on the 18th of December at the Forest Park Community Building, 113 East 5th Street, Appleton City, MO 64724.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

Appleton City hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects shall provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

Appleton City reserves the right to reject any or all bids.

The project will be awarded to the lowest, responsive, responsible bidder.

The DBE Goal for this project is 7.00%.

No 2nd tier subcontracting will be allowed on this project.
