A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The contract, if awarded, will be awarded to the lowest, responsive, responsible bidder complying with the Conditions of the Contract Documents within the Owner's budget. The Bidder to whom the awards are made will be notified at the earliest possible date.
