Sealed proposals will be received at the Office of Ste Genevieve County, 55 South Third Street, Ste Genevieve, Missouri 63670, until 9:00 AM ON NOVEMBER 13, 2014.

The project consists of furnishing all labor, tools, equipment and materials for construction of a replacement structure including the removal of existing improvements, excavation and embankment construction, pile placement, reinforced concrete end bents construction, furnishing and placement of precast, prestressed concrete deck beams, rip rap placement, approach road construction and surfacing and other associated items to complete the project in accordance with the plans and specifications prepared by Koehler Engineering and Land Surveying, Inc.

Proposals will be publicly opened and read aloud at <u>9:00 AM ON NOVEMBER 13, 2014</u> within the Office of Ste Genevieve County, 55 South Third Street, Ste Genevieve, Missouri 63670. All bidders are required to purchase plans and specifications in order to submit a bid for this project.

The Contract provides for the furnishing of all labor, equipment, and materials necessary for the improvement and construction required per the improvement plans, specifications and construction documents.

A certified or cashier's check, or bid bond executed by the bidder and by an approved Surety Company, in the amount of five (5) percent of the bid shall be submitted with each Proposal.

A **non-refundable** fee of \$\_75.00 per set is required. All bidders are required to purchase plans and specifications to submit a bid for this project.

All wages paid for work under this Contract shall comply with requirements of the current prevailing wage law of the State of Missouri, Sec. 290.210 through 290.340, R.S. Mo. 1978, as amended. Bidders must agree to comply with all statutory regulations referred to in the specifications. Weekly certified payrolls will be required from the General Contractor and all Subcontractors.

The Disadvantaged Business Entity (DBE) goal for this project is 7%. No 2<sup>nd</sup>-Tier subcontracting is permitted under this contract.

A pre-bid conference will be held at 9:00 AM, local time, November 3rd at the Office of Ste Genevieve County, 55 South Third Street, Ste Genevieve, Missouri 63670. Representatives of the Owner and Engineer will be present to discuss the project. **Bidders are not required to attend and participate in the pre-bid conference.** The Engineer will transmit to all prospective Bidders of record such Addenda as Engineer considers necessary in response to questions arising at the conference. Oral statements may not be relied upon and will not be binding or legally effective.

The Ste Genevieve County Commission hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

The project will be awarded to the lowest, responsive, responsible bidder. The Owner reserves the right to waive all informalities not involving price, time or changes in Work and to negotiate contract terms with the Successful Bidder.

Pursuant to 285.530 R.S. Mo, the bidder must affirm its enrollment and participation in a federal work authorization program with respect to the employees proposed to work in connection with the services requested herein by including with the bid proposal 1) submitting a completed, notarized copy of AFFIDAVIT OF WORK AUTHORIZATION and 2) providing documentation affirming the bidder's enrollment and participation in a federal work authorization program with respect to the employees proposed to work in connection with the services requested herein.

Additionally, pursuant to 292.675, R.S. Mo, the bidder is informed that all contractors or subcontractors doing work on this project to provide, and required it on-site employees to complete, a ten (10) hour course in construction safety and health approved by the Occupational Safety and Health Administration ("OSHA") or similar program approved by the Missouri Department of Labor and Industrial Relations which is at least as stringent as an approved OSHA program. The training must be completed within sixty (60) days of the date work on the project commences. On-site employees found on the worksite without documentation of the required training shall have twenty (20) days to produce such documentation.
