Revision: Paragraph 12 has been revised to read "Gorman Rupp Roto Prime or equivalent Pump with a 7 hp 240V single-phase explosion proof motor & explosion proof starter."

SP-1 : AVGAS FUELING SYSTEM

Page: SP-1-6

Revision: Paragraph 17 DELETE the words "Hose: 1-1/2" (Inside Diameter)" and REPLACE with the words "Hose: 1" (Inside Diameter)".

SP-1 : AVGAS FUELING SYSTEM

Page: SP-1-7

Revision: The first sentence of Paragraph 18 has been revised to read "Hose Reel: Shall be compatible with a 1" inside diameter hose 50' in length."

### 3. <u>QUESTIONS</u>

a.) For the Schedule II Bid Alternates should the bidders provide bid alternates for both the concrete and asphalt bid alternates when filling out the Bid Proposal Form? *Answer: When filling out the Bid Proposal Form bidders shall provide a bid for Schedule I and the Schedule II Base Bid plus a bid for either Bid Alternate No. 1 - Concrete or Bid Alternate No. 2 - Asphalt.* 

b.) For the 5' wide butt joints shown on Sheet 8 of 22 DEMOLITION PLAN how deep is the milling of the butt joints in the existing asphalt? *Answer: The Demolition Legend refers to Specification MO-601 SURFACE PREPARATION.* 

The MO-601 specification under the METHOD OF MEASUREMENT Section 601-4.1 paragraph b describes cold milling 2" and replacing with 2" of bituminous surface course.
