The proposed work includes:

Grading, constructing a 39'-52'-39' Cont. R.C. haunched slab spans, skewed 30° L.A., and a 24'-0" roadway with a Type 1 Aggregate Surface, on the above road where it crosses over Coldwater Creek approximately 3.2 miles South and 2.6 miles West of Freeman, Missouri.

The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962," (P.L. 87-581; 76 Stat. 357) and implementing regulations. No refund will be made to the successful bidder. Twenty-five percent of the deposit will be refunded to all other plan holders upon receipt of returned plans and specifications IN GOOD CONDITION WITHIN FIFTEEN (15) DAYS AFTER OPENING OF BIDS. The successful bidder will be furnished three complete sets of plans and specifications. If additional sets are needed, they will be sold to him at cost.

Note:

All prime contractors must be on MoDOT's Approved Contractor Listing 7 days prior to bid opening. DBE Sub-Contractors must be on the MRCC DBE Directory prior to Bidding.

The Prime Contractor must have a fully responsive contractor questionnaire on file with the Missouri Highways and Transportation Commission (MHTC) at least seven (7) days prior to the bid opening date.

Missouri Law, 292.675 RSMO, requires the awarded contractor and its subcontractors (S) to provide a ten-hour occupational safety and health administration (OSHA) construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations as a qualified substitute) for their on-site employees (laborers, workmen, drivers, equipment operators, and craftsmen) who have not previously completed such a program and are directly engaged in actual construction of the improvement (or working at a nearby or adjacent facility used for construction of the improvement). The awarded contractor and its subcontractor (s) shall require all such employees to complete this ten-hour program, pursuant to 292.675 RSMO, unless they hold documentation on their prior completion of said program. Penalties for non-compliance include contractor forfeiture to Cass County in the amount of \$2,500, plus \$100 per contractor and subcontractor employee for each calendar day such employee is employed beyond the elapsed time period for required program completion under 292.675 RSMO.
