The bid documents will be available on October 13, 2014. The base bid of this project will provide a Heavy Duty Multi-Purpose Carrier Vehicle with a two stage loader mounted snow blower installed, delivered and ready for operation. The Additive Bid Items consist of Additive Alternate 1.) Providing a 60 Month, 5,000 Hour, Full Machine Extended Warranty; and Additive Alternate 2.) Providing a 42" Tall 14 Foot Wide Bucket Attached Snow Pusher.

This project is subject to the requirements of 49 CFR Part 26 Disadvantaged Business Enterprise Participation. The owner has established a contract goal of **0.0%** participation for small business concerns owned and controlled by qualified disadvantaged business enterprises (DBE). The bidder shall make and document good faith efforts, as defined in Appendix A of 49 CFR Part 26, to meet the established goal.

No bid will be considered unless accompanied by a certified check or cashier's check on any bank or trust company insured by the Federal Deposit Insurance Corporation, payable to **City of Cape Girardeau, Missouri** for not less than five (5) percent of the total amount of the bid, or by a bid bond secured by an approved surety or sureties, payable to the owner, for not less than five (5) percent of the total amount of the bid including bid alternates.

Bids may be held by the **City of Cape Girardeau, Missouri** for a period not to exceed **45 days** from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The right is reserved by the **City of Cape Girardeau, Missouri** to reject any bid and also the right to reject all bids.
