2.01 This Addendum forms a part of the Contract Documents and modifies the Bidding Documents, with amendments and additions noted below.

Item #1

The following questions have been received and the answers will be listed next to the questions.

Q1. The plans call for the trail markers to be stone and to match the existing size of the Blue River markers; the plans also show the markers being 8" x 8". The existing markers appear to be colored concrete made to look like wood. The size of the existing markers is 5 1/2" x 5 1/2".

Answer 1-Bid 5 1/2" x 5 1/2" concrete post and installation. Sign is provided by other. Specification is attached to Addendum #2.

Q2. Bid item 26 states that the quantity for the split rail is 56 EA. On the plans on page 5 and 6 it calls out for 50 LF, can you confirm which is correct?

Answer 2- Revised bid sheet is attached and is marked Addendum 2. Item 26 on the bid sheet should read 56 linear feet.

Q3. On Specification Section 02221-The removals says to remove existing sidewalk to pavilion. Are we to remove entire sidewalk from pavilion to access road, from pavilion to new trail or just the portions that the new 10' trail goes through?

Answer 3-Remove entire existing walk from parking area to pavilion. Do not remove any of the shelter pad concrete.

Q4. On Specification Section 02221 the existing trail near intersection with old red bridge trail- are we to remove entire trail or just where the new 10' trail crosses?

Answer 4- Remove only section of trail where the new trail crosses existing trail.

Q5. On Specification Section 02221 is the flume removal on the access road referred to page 7 where it states existing flume connecting to P-3?

Answer 5- Flume is located at approximately station 29+00

Q6. Bid item 18-There is not pay item for permanent seeding without straw mat? The 10,000 SY of "permanent seeding with straw mat" Does not appear to be enough to final seed the project (we are clearing 5 acres). Do we need to figure permanent seeding in other pay items?

Answers 6- A revised bid sheet that is attached and is marked Addendum 2. Do not figure permanent seeding in other pay items. Item 19 for temporary seeding should read 7,517square yards. Item 30 adds 5,000 sy of permanent seeding with mulching was added as line item and reads 5,000.

Q7. In regards the temporary seeding and mulching, what does the quantity of 5000 SY include? Is it a contingency for whatever temporary seeding may be required or is this figured for a certain area?

Answer 7- Temporary seeding will occur as necessary for disturbed areas that need vegetative cover before final seeding can occur. Item 19 for temporary seeding should read 7,517square yards. Revised bid sheet that is attached and is marked Addendum 2.

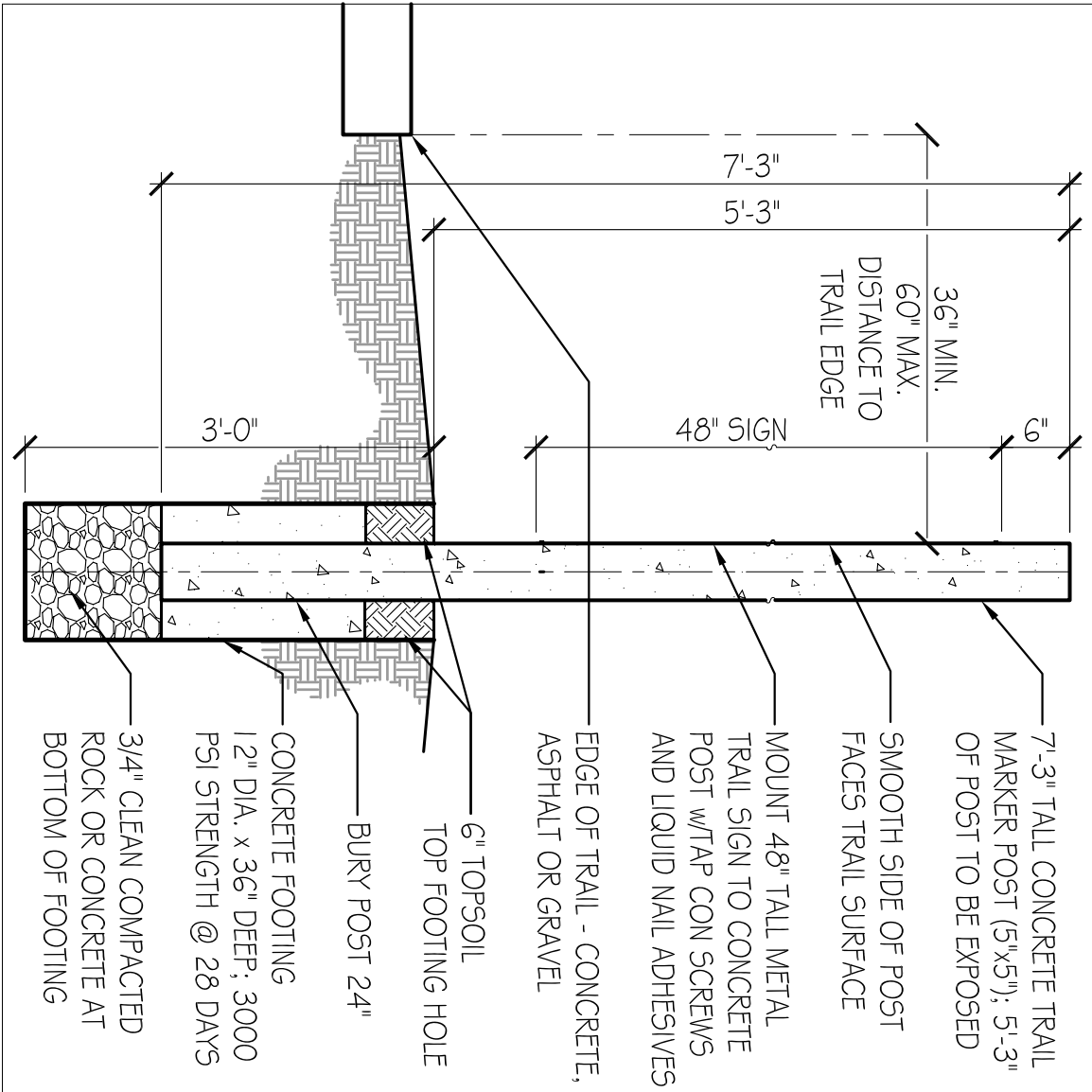
