

**Conway Road Sidewalk Improvement Project
Spoede Road to Lindbergh Boulevard

Notice to Contractors

Sealed bids for the Conway Road Sidewalk Improvement Project, STP-5503 (606) will be received at: The City Of Frontenac City Hall 10555 Clayton Road Frontenac Missouri 63131, until **2:00 o'clock P.M. (Prevailing Local Time) on Thursday, the 10th day of September, 2014**, at the 1st Floor of City Hall, and at that time will be publicly opened and read. All bids shall be submitted sealed and clearly marked: **Conway Road Sidewalk Improvement Project - STP-5503 (606)** and at that time will be publicly opened and read.

The proposed project consists of installing approximately 2800 linear feet of new concrete sidewalks, on one side of the street, and associated curb ramps within current ADA standards along Conway Road between Spoede Road and Lindbergh Boulevard in Frontenac, Missouri. Additionally, a new concrete curb and gutter system will be installed on both sides of the street allowing better stormwater drainage for future street resurfacing purposes and any incidental work as deemed by the City. The duration of the project shall be limited to 60 calendar days.

Plans and specifications are available through Drexel Technologies eDistribution Plan Room web site (<http://planroom.drexeltech.com>). Log on using your email address as your Username, and first initial followed by your last name as your password. If you do not already have an account, setting one up is free of charge. Once you are logged in, click on Public Jobs and then scroll down to the St. Louis Plan Room for this particular City of Frontenac project. Any addendum to the plan set will be forwarded to all plan holders.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Frontenac hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.”

All bidders must be on the Missouri Department of Transportation’s (MoDOT’s) Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier’s check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Frontenac, Missouri reserves the right to reject any or all bids.

The DBE Goal for this project is 12%. No 2nd tier subcontracting will be allowed on this project.
