The units for item number 99-00052, "PARKING BLOCK (Includes Asphalt Anchor)", shall be revised from square yards (SY) to each (EA).

The Engineer will coordinate the approval of an alternate pavement marking product to epoxy, if proposed, with Great Rivers Greenway, City of St. Louis and Missouri Department of Transportation. The substitution and approval of the durable marking product alternative to Epoxy is at the sole discretion of Great Rivers Greenway, City of St. Louis and Missouri Department of Transportation, however, it cannot be a product that uses grinding or damages the pavement in any way during application.

The Term "EPOXY or DURABLE MARKING PRODUCT APPROVED BY THE ENGINEER" shall also replace "EPOXY" on all references for pavement markings included on quantity sheets SQ5A, SQ6A, and striping legend sheet L26.
