The following modifications shall be made in the Contract Documents. The cost thereof shall be included in the proposals submitted by bidders.

CONTRACT DOCUMENTS CHANGES:

- Bid Form Page BF 1 of 12, The units for item number 99-00038, "CONCRETE CURB RAMP (8")", shall be revised from SQUARE FEET (SF) to SQUARE YARDS (SY).
- 2. Plan Sheets SQ6 and SQ6a shall be replaced as follows:
 - a. SQ6 (Sign and Sealed 6/23/14) included a Summary of Quantities for Des Peres Road that included units for "Concrete Curb Ramp" of SF. This sheet shall be completely replaced by SQ6 (Sign and Sealed 7/23/14) that included a unit cost for "Concrete Curb Ramp" as SY.
 - b. SQ6a (Sign and Sealed 5/07/14) included a summary of quantities for Des Peres Avenue and did not include a summary of quantities for Add alternates for bike corrals, shall be completely replaced with SQ6a (Sign and Sealed 7/23/14) which eliminates the summary of quantities for Des Peres Avenue, and adds a summary of quantities for bike corral add alternates.

Note: All quantities included in the Bid Form are correct.


