Any and all bids received after the time specified above will be returned unopened.

The proposed work involves replacement of a low water crossing on Vaughn Ford Road over the South Moreau Creek in Cole County, Missouri. The project will include a realignment of the roadway with grading and gravel surface and concrete pavement work, seeding, erosion control placing rock bank protection, and constructing concrete slope protection as well as construction of a single span bridge consisting of pile cap end bents with a pre-engineered precast superstructure. All equipment, material and workmanship must be in accordance with the plans, specifications, and contract documents on file with the Director of Cole County Public Works.

The wage rates applicable to this project have been predetermined as required by law. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations.

Cole County hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects must provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.
