**Project Description:** The project will generally consist of the removal and replacement of approximately 2,820 lineal feet of concrete/brick sidewalk which includes concrete driveway apron replacements, truncated domes, a small retaining wall/ramp, traffic control, vegetative restoration, and pavement marking.
