Asphalt pavement reconstruction, widening and cold planing and overlay; concrete sidewalk, curb and gutter and retaining walls; enclosed storm sewer system, water main and services, sanitary sewer and lighting conduit; pavement marking, signing and temporary traffic control; erosion control, sod, fence, landscaping, handrail and other miscellaneous construction items.

The contractor shall agree to take all necessary affirmative steps required to assure that the Disadvantaged Business Enterprise (DBE) goal of ten-percent (10%) of the total federal contract is used when possible, when procuring supplies, equipment, construction and services related to this project as set forth in the contract documents.

Sec. 292.675 & RSMO Chapter 536 preclude the employment of any illegal aliens on this project. See enclosed FAWP-1 for penalties and OSHA requirements.

This project is subject to the requirements of Section 292.675, RSMo, which requires Contractor and Subcontractor on-site employees to complete a ten (10) hour course in the construction safety and health approved by the Occupational Safety and Health Administration (OSHA).

A satisfactory bid bond executed by the bidder and an acceptable surety, in an amount equal to five percent, (5%) of the total bid for work shall be submitted with each proposal. The successful bidder will be required to furnish and pay satisfactory performance and payment bond or bonds.

The City of Liberty, Missouri reserves the right to reject any or all bids or to waive any informality in the bidding.

Bids may be held by the City of Liberty, Missouri for a period not to exceed sixty (60) days from the date of the opening of bids for the purpose of reviewing the bids and investigating the qualifications of bidders, prior to awarding the contract.
