

**ADVERTISEMENT FOR BIDS**  
**BYARS ROAD MULTIUSE PATH ENHANCEMENTS**

The City Clerk, or designated representative, of the City of Grandview, Missouri, will receive sealed bids for the **BYARS ROAD MULTIUSE PATH ENHANCEMENTS** until 10:00 a.m., on the 20th day of May, 2014, at the Municipal Services Building, 1200 Main Street, Grandview, Missouri 64030, at which time all bids received will be publicly opened and read aloud.

The contract provides for: Construction of approximately 835 SY of concrete multi-use trail; grading; construction of approximately 20 LF of concrete culvert and end section; installation of a beacon-style pedestrian crossing signal and associated utility connections; construction of approximately 97 SY of concrete sidewalk; construction of a custom steel shelter with polycarbonate roof and masonry-wrapped posts; provision and installation of site furnishings including a bike rack, trash receptacle, bench, and water bottle filler with pet water station; ADA enhancements; landscaping and irrigation system.

No digital files will be released for self-printing during the bidding phase.

The DBE Goal for this project is 8%.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher. The project is subject to the requirements of RSMo Sec. 292.675 concerning worker safety. Pursuant to RSMo Sec 285.530 bidders are required to submit, or have on file with the City of Grandview, the Worker Eligibility Verification affidavit within the contract documents.

**The Owner will award the bid to the lowest responsible and responsive bidder; The City of Grandview reserves the right to reject any or all bids; and to waive irregularities or informalities in any bid submitted. Bids received after the specified time of closing will be returned unopened.**

The City of Grandview hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
