Notice to Contractors

Sealed bids for **Black Knight, Westmount, and Maple Valley Drives Sidewalks**, Project No. STP-2500(005), will be received at City of Farmington, Public Works Office, 12 S. Franklin Street, Farmington, MO 63640, telephone 573-756-0608, until 1:30 P.M. (Prevailing Local Time) on the 21st day of May, 2014, at the office of the Public Works Director, and at that time will be publicly opened and read.

All bids shall be submitted on paper using the Bid Form included with the Bid Document, in ink, and in a sealed envelope identifying the name of the Bidder, and the project number and name as follows: Bid for Project No. STP-2500 (005), Black Knight, Westmount, and Maple Valley Drives Sidewalks.

The proposed work includes the construction of concrete sidewalks, curbs, and gutters and related work such as pavement removal, grading, seeding, traffic control, erosion control, fencing, and pavement marking.

A pre-bid conference will be held at 1:30 PM on the 14th day of May, 2014, at the Public Works Office, 12 S. Franklin Street, Farmington, MO. All bidders are encouraged to attend the pre-bid meeting.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Farmington hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project shall provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Farmington reserves the right to reject any or all bids.

The DBE Goal for this project is 10%.

No 2nd tier subcontracting will be allowed on this project.
