All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

Missouri Annual Wage Order 20 as amended January 23, 2014 shall be in effect for this project.

Missouri Law, 292.675 RSMO, requires any awarded contractor and its subcontractor(s) to provide a ten-hour Occupational Safety and Health Administration (OSHA) construction Safety Program (or a similar program approved by the Missouri Department of Labor and Industrial Relations as a qualified substitute) for their on-site employees.

The DBE goal for this letting is a minimum 12% (twelve percent) of the total contract amount.

All BIDDERs must meet the MoDOT requirements as a CONTRACTOR at least seven days prior to bid opening.
