LADUE ROAD IMPROVEMENT PROJECT

Sealed bids for the Ladue Road Improvement Project 2013-PW-05, Federal Project STP-4901(628) will be received at Chesterfield City Hall (690 Chesterfield Parkway West, Chesterfield, MO 63017) until 10:00 am (prevailing local time) on the 29 day of April, 2014 and at that time will be publicly opened and read. All bids shall be submitted in paper form.

The proposed work includes the removal and replacement of approximately 35,070 square yards of pavement on Ladue Road between Olive Boulevard and Crosstrails Drive with 8-inch Portland cement concrete (PCC) pavement with longitudinal and transverse reinforcement or 7-inch PCC pavement, over 4-inches of Type 5 Aggregate over a geotextile layer on a prepared subgrade. Work will also include but may not be limited to underdrains, expansion joints, striping, restoration, traffic control, driveway aprons, sidewalk, curb ramps, and all other necessary and incidental work to make for a complete and usable roadway. Staged construction will be required to maintain traffic on Ladue Road during the construction of this project.

Bid packets and plans, in the form of ".pdf" electronic files on a compact disk (CD) will be available at Chesterfield City Hall beginning April 2, 2014. When picking up or receiving a bid packet CD, you will be required to provide your name and company information on a bidder's list record and furnish an email address for receiving official bidding communications and addenda. Communications between the bidders and the City shall be conducted and documented in writing through the use of email communication to zwolff@chesterfield.mo.us. No oral interpretation will be recognized.

A pre-bid conference will be held at 10:00 am on the 16 day of April, 2014, at Chesterfield City Hall. **All bidders** are encouraged to attend the pre-bid meeting.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Chesterfield hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, business owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Chesterfield reserves the right to reject any or all bids.

The DBE goal for this project is 8%.

No 2nd tier subcontracting will be allowed on this project.
