A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

A DBE goal of (5%) Five percent has been established for this project. All DBE's must be certified and be listed in either the MoDOT DBE Directory or the MRCC DBE Directory.

The prime contractor must perform with his own forces at least 30 percent of the total contract amount.

The engineer's technicians who perform, or are required by the FHWA to witness, such sampling and testing shall be deemed as qualified by virtue of successfully completing the requirements of EPG 106.18 Technician Certification Program, for that specific technical area.
