

INVITATION TO BID

City of Kearney, Missouri Kearney Elementary Crosswalk Improvements

The City of Kearney, Missouri will receive sealed Bids until 2:00 p.m. on March 27, 2014, at the City of Kearney City Hall located at 100 East Washington Street, Kearney, Missouri 64060 for the construction of the Kearney Elementary Crosswalk Improvements Project (MoDOT Job No. SRTS-INF-H32C(104)); at which time and place, Bids will be opened and publicly read.

The work consists of the following:

Improvements to be completed under this project include: concrete sidewalk; ADA sidewalk/curb ramps: curb and gutter; school crosswalk flashers; school signing and other necessary and incidental work as required.

Contract Documents including drawings and specifications are on file at City Hall of Kearney, Missouri and are open for public inspection.

Prospective bidders desiring the Contract Documents for use in preparing bids may obtain a set of such documents from Trekk Design Group, LLC, 1441 East 104th Street, Suite 105, Kansas City, Missouri 64131 upon payment of \$55.00 for full size plans and specifications, \$35.00 for half size plans and specifications, and \$25.00 for a CD or download (payable to Trekk Design Group, LLC) which is non refundable. Affirmative Action – The City of Kearney, Missouri hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

OSHA Training - Missouri Law, 292.675 RSMO, requires the awarded contractor and its subcontractor(s) to provide a ten-hour occupational safety and health administration (OSHA) construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations as a qualified substitute) for their on-site employees (Laborers, Workmen, Drivers, Equipment Operators, and Craftsmen) who have not previously completed such a program and are directly engaged in actual construction of the improvements (or working at a nearby or adjacent facility used for construction of the improvements). The awarded Contractor and its subcontractor(s) shall require all such employees to complete this ten-hour program, pursuant to 292.675 RSMO, unless they hold documentation on their prior completion of said program. Penalties for non-compliance include contractor forfeiture to the City of Kearney, Missouri in the amount of \$2,500, plus \$100 per contractor and subcontractor employee for each calendar day such employee is employed beyond the elapsed time period for required program completion under 292.675 RSMO.

DBE subcontractors must be on the MRCC DBE Directory prior to bid opening. The DBE goal for this project is 0% and is to be applied to the BASE BID ONLY.

A satisfactory bid bond executed by the bidder and an acceptable surety, in an amount equal to five percent, (5%) of the total base bid for work shall be submitted with each proposal.

The successful bidder will be required to furnish and pay satisfactory performance and payment bond or bonds.

The City of Kearney, Missouri reserves the right to reject any or all bids or to waive any formalities in the bidding.

Bids may be held by the City of Kearney, Missouri for a period not to exceed sixty (60) days from the date of the opening of bids for the purpose of reviewing the bids and investigating the qualifications of bidders, prior to awarding the contract.

The project will be awarded to the lowest, responsive, responsible bidder.
