An endorsed "Proposal" for construction of the proposed "SRTS INF-H284 (104), Public Sidewalk Improvements - South Street Sidewalk" in Richmond, MO - 2014, will be received by the City of Richmond until 2:00 PM (Prevailing Local Time) on Friday, March 14 at the City of Richmond City Hall and, at that time, will be publicly opened and read.
