**Notice to Contractors**

Sealed bids for City of Peculiar, Missouri, Entrance Monument Sign Project, Federal Project No. STP-9900 (491) will be received at: City Hall 250 S. Main Street Peculiar, Missouri, 64078 until 3:00 o'clock P.M. (Prevailing Local Time) on the 25<sup>th</sup> day of March, 2014, at the office of the City Clerk, Nick Jacobs, and at that time will be publicly opened and read. All bids shall be submitted in the form of a complete set of bidding documents as indicated in the "Invitation to Bid" section of the Project Manual.

The proposed work includes: the installation of a masonry sign, letters, lighting, curb & gutter, sidewalk, concrete paving, trees, shrubs, seeding, irrigation system, earthwork, and cleanup as shown on the Contract Documents prepared by Landplan Engineering, P.A. dated January 31, 2014.

Plans and specifications may be downloaded free by going to the Landplan Engineering web site at [www.landplan-pa.com](http://www.landplan-pa.com). Click on the "Contractor SharePoint Site" in the middle / bottom of the home page. Enter the user name: **contractor**. Enter the password: **landplan908**. Click on project folder; and click on the appropriate subfolder as indicated in the "Invitation to Bid". One (1) copy of the Project Manual, including Specifications, plus one (1) set of prints of the Drawings for viewing shall be located at Landplan Engineering, Livestock Exchange Building, 1600 Genessee, Suite 400, Kansas City, Missouri 64102; and at City Hall 250 S. Main Street, Peculiar, Missouri, 64078.

A pre-bid conference will be held at 1:30 PM on the 18th day of March, 2014, at Peculiar City Hall 250 S. Main Street, Peculiar, MO 64078. **All bidders are encouraged to attend the pre-bid meeting.**

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Peculiar, Missouri hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Peculiar reserves the right to reject any or all bids.

The DBE Goal for this project is eight (8) percent.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
