

INVITATION TO BID

VERONA - PHASE I SIDEWALK IMPROVEMENTS

Sealed bids for the "Proposal for Sidewalk Improvements along 3rd, 2nd, and Dora Streets in Verona, Missouri" will be received at: City of Verona, 144 N. 3rd Street, Verona, MO 65769 until 10:00 o'clock A.M. (Prevailing Local Time) on the 19th day of February, 2014, at the office of the Verona City Hall, 144 N. 3rd St., Verona, MO 65769, and at that time will be publicly opened and read. All bids shall be submitted as a Hard Copy.

The proposed work includes:

Sidewalk Improvements along 3rd, 2nd, and Dora Streets within the City of Verona, Missouri. All new sidewalks and approaches shall meet current ADA accessibility guidelines. Approximately 1150 LF concrete sidewalk, ADA ramps, storm water conveyance, handrail, etc.

Plans and specifications may be purchased at the office of the Great River Associates (GRA), at 2826 S. Ingram Mill, Springfield, MO 65804 upon payment of \$75.00, which is not refundable. All bidders must purchase plans through Great River Associates, Inc. and be on the planholder list in order to bid the project. A pre-bid conference will be held at 2:00 P.M. on the 11th of February at the office of Great River Associates, 2826 S. Ingram Mill Road, Springfield, MO 65804.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Verona hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects shall provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Verona reserves the right to reject any or all bids.

The project will be awarded to the lowest, responsive, responsible bidder.

The DBE Goal for this project is 6.00%.

No 2nd tier subcontracting will be allowed on this project.
