

# NOTICE TO BIDDERS

Sealed Bids for **Sealed Bid Number SB13-184** will be received by the St. Charles County Purchasing Manager, 201 North Second Street, Suite 541, St Charles, Missouri 63301, Until 10:00 A.M., (prevailing Central Time) on January 6, 2014 and will thereafter be publicly opened and read aloud in Conference Room 431.

The proposed work includes the furnishing of materials, tools, equipment and labor necessary to construct **MINOR TRAFFIC SIGNAL UPGRADES** in St. Charles County, Missouri.

The construction shall include all work incidentals to the furnishing of materials, tools, equipment and labor necessary to construct minor traffic signal upgrades to ten County maintained signalized intersections; Retrofitting existing signals to current standards to achieve MUTCD compliance pertaining to; Sign reflectivity, symbol/message types, colors, & size; Signal head types (Walk & Vehicle), their positions, lens types, installing flashing yellow arrows, and phasing changes. Improvements to reduce emissions and increase traffic flows in accordance with the Gateway Green Light project goals and compliance. Install fiber optic cable and wireless interconnect to improve communications between signals. Install improved vehicle and pedestrian detection. Perform various equipment programming services, and other appurtenances in St. Charles County, Missouri.

Plans and specifications may be obtained on and after Monday December 2, 2013 for a **\$50** non-returnable fee at the office of the St. Charles County Highway Department, 201 N. Second Street, Suite 429, St. Charles, Missouri. Sets will be mailed upon request for a non-returnable fee of **\$80** after a check is received. Make all checks payable to "**St. Charles County Highway Department.**"

Each Bid must be accompanied by a Cashier's Check or Certified Check, or a Bid Bond executed by the Bidder and an approved Surety Company and payable to the County, in an amount not less than Five Percent (5%) of the Sum Total of the Base Bid.

Not less than the prevailing hourly rates of wages as found by Federal Wage Rates, or determined by court on appeal, shall be paid to all workers performing work under this Contract. Missouri Annual Wage Order 20 shall be in effect for this project.

The DBE goal for this letting is a minimum of **12%** of the total contract amount.

TRAINEES: No trainees will be required under this contract.

All contractors and subcontractors are subject to and must comply with the Safety Program Training requirements of Section 292.675 of the Revised Statutes of Missouri.

All requests for clarifications on these bidding documents must be received in writing at least one week prior to the bid opening.

All bidders must meet the MoDOT requirements as a CONTRACTOR at least seven (7) days prior to bid opening in accordance with Section 102.2 of the St. Charles County Standard Specifications for Arterial Highway Construction.


A Performance Bond and Payment and Materials Bond are required.
